Re: Notice of Potential Plant Closing / Mass Layoff

Dear Members of the Dislocated Worker Unit:

Please be advised that Inmar expects to effectuate a closure of its entire facility located at 6101 N. 64th Street, Milwaukee, Wisconsin 53218 and that facility closure may result in a plant closing or mass layoff as defined by the Worker Adjustment and Retraining Notification Act ("WARN"). Approximately 265 employees will have their positions eliminated as a result of the facility closure and are expected to experience an employment loss. Most of the separations are expected to occur between June 15 and August 31, 2019. The elimination of these positions will be permanent, and there are no applicable bumping rights. A list of the job titles of positions affected and the number of employees affected in each job title is attached hereto as Exhibit A.

All employees who can reasonably be expected to experience an employment loss have been notified of the impending facility closure and will be offered severance packages, assuming they otherwise remain eligible for such a package. In addition, the appropriate local official has been notified of the facility closure. These employees are not represented by a union.
