Re: Notice of Immediate Business Closing

Dear Members of the Dislocated Workers Unit and Local Officials:

Forrer Business Interiors, Inc., (“FORRER”) is closing its business and permanently closing its facility located at 555 West Estabrook Blvd, Milwaukee, Wisconsin 53212 (the “Facility”). Due to a sudden and unforeseen change of business circumstances, FORRER’s business closing is effective immediately. Both FORRER and the Facility will permanently close today, August 2, 2019, at 5:00 p.m.

As a result of FORRER’s business closing, the employment of each of the 58 employees at the Facility will be terminated today. All affected employees have been notified of their terminations and the fact that the terminations will be permanent.

Some of FORRER’s employees are represented by International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America, known in short as the “Teamsters,” referred to hereinafter as the “Union,” on behalf of itself and Teamsters “General” Local Union No. 200. The local representative of this union is Mr. Thomas J. Bennett. Mr. Bennett is located at 6200 W. Bluemound Rd., Milwaukee, WI 53213.
