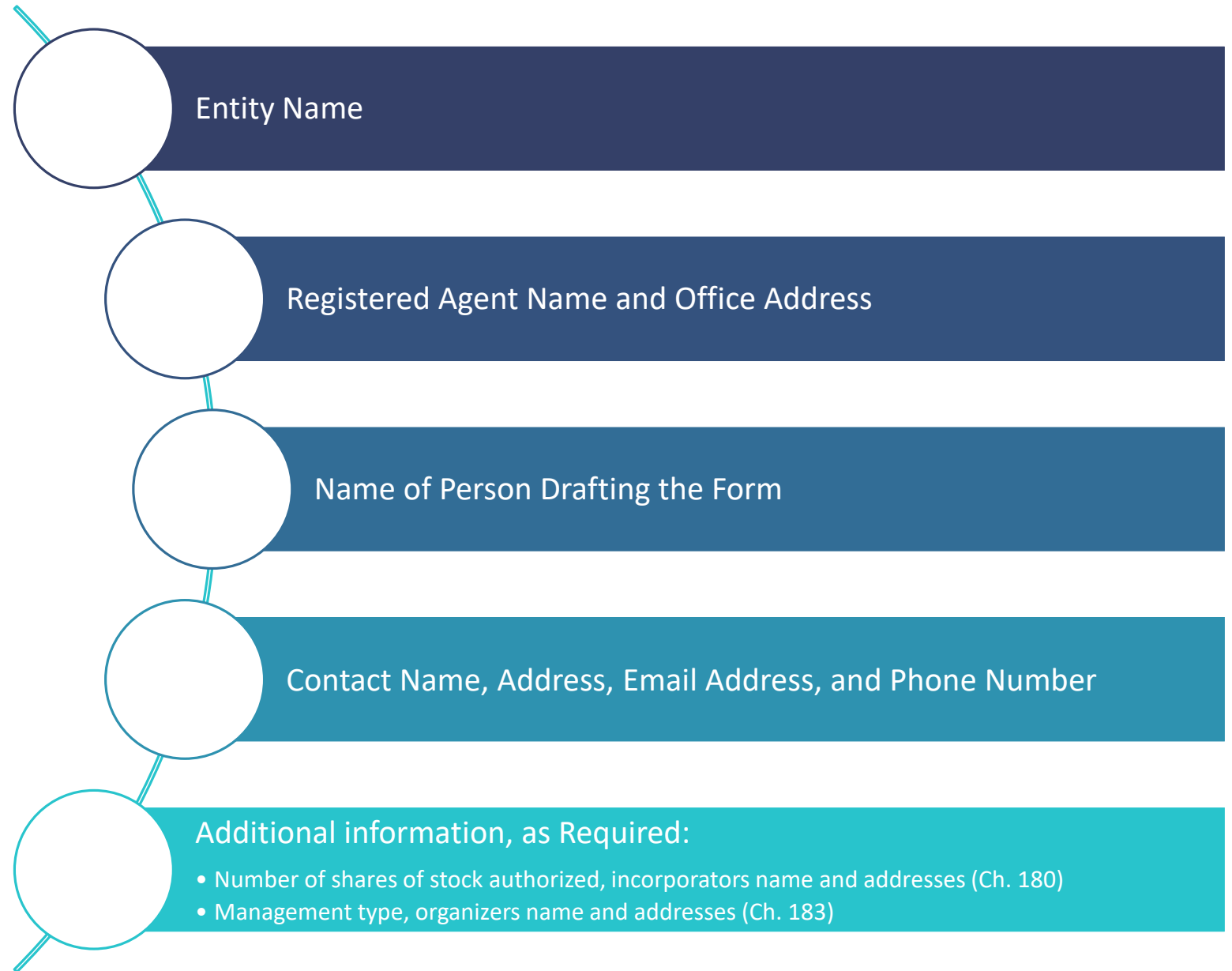

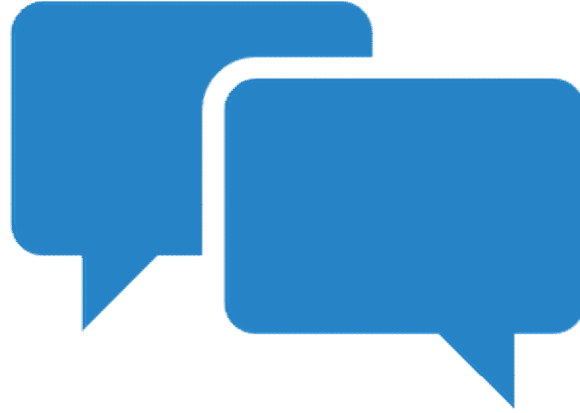
Recommendation #2
