Meeting Notes

A. Workgroup Updates

- DFI Registration Cynthia Buchko- reported on members Marc Shovers, David Haushalter and Tim DeMinter. They met yesterday to plan. Next meeting is August 23 at 1pm. New members will include Sen. Kooyenga, Maria Guerra Lapacek, and representatives from other state agencies.
- 2. **Upstream Liability** Mark Reihl The group did not meet but Mark will be contacting the members next week to schedule meetings. So far, the members are Jerry Shea, Nathan Jurowski, Andy Buck, Mike Morris and Rep. Sinicki. Mark will be reaching out to schedule next week.
- 3. Independent Contractor Test Steve Peters The group will meet soon to review the tests across the divisions, federal tests and other state tests, including California. Identify strengths and weakness of the tests and make a recommendation of whether Wisconsin should change its tests to a unified test. Right now, only Stu Wilson has volunteered to be on the committee. Steve asked that others who are interested in being part of the group contact him.

The group continues to work with DFI to understand their enforcement limitations. DOR now includes language in the findings letter that they may or may not be registered with DFI and the penalties for not complying.
